We are pleased to be able to recognize and award the academic accomplishments and accolades of our beneficiaries who are enrolling in and/or are going to be enrolled in: college post-secondary, technical, trades, and/or vocational programs within Alberta.

FOR ALL AWARDS, BURSARIES, AND SCHOLARSHIPS ELIGIBLE APPLICANTS MUST BE:

- Meet the Low-Income Cut-off Guidelines (LICOs) thresholds;
- o Diagnosed with autism, identify as experiencing autism, and/or neurodiversity;
- Experiencing barriers accessing accommodations within an educational institution, retaining employment and/or accommodations within the workplace;
- In need of support (s) and/or service (s) such as: advancement of education, financial, relief of poverty, socialization, and/or social integration; and
- Currently live in Alberta and enrolling and/or enrolled in an Alberta college, post-secondary, technical programs, trades and/or vocational program.

Note: students who have applied for entry into a college, post-secondary, technical programs, trades and/or vocational program but have not yet been accepted may still apply for our awards, scholarships, and/or bursaries. The final selected applicant (s) will need to provide a copy of their chosen post-secondary institution acceptance letter once accepted in order to be awarded with the scholarships and/or bursaries.

Please be advised, individuals that are AFLF contractors, directors, employees, members, officers, practicum students, and/or volunteers and their immediate family members are not eligible to apply for and/or receive AFLF awards, bursaries, and/or scholarships.

APPLICATION REQUIREMENTS | APPLICANTS MUST

• Complete the AFLF awards, bursaries, & scholarships application form.

If you require accommodations to complete the application provided, please apply in the manner that suits your skill set best, and we will ensure to accommodate that applicant to the point of undue hardship. If you are non-verbal and/or cannot type we will accept letters of recommendations from community members, teachers and/or professors.

- I. Academic performance, community, and/or academic involvement;
 - Please provide a description of your post high school training program. Include the following details - School attending (i.e. University of Calgary or Mount Royal), Program of Study (i.e. Bachelor of Science or Transitional Vocational Program), speciality if applicable (i.e. Biology), and anticipated date of graduation. *Scoring value 10/100*
 - **ii.** Please provide a brief description of your volunteer activities, special interests and accomplishments. *Scoring value 20/100*
 - iii. Please provide a brief description (250 words maximum) about how being a student on the autism spectrum has impacted your education. *Scoring value 40/100*
- II. Completeness of the application form;
- III. Letters of recommendation Scoring value 60/100 in lieu of essay's; and
- **IV.** Future goals and ability to complete future goals and accolades.
 - iv. Please provide a brief description of your future education and employment goals. Scoring value 30/100

JUDGING AND AWARDING SCHOLARSHIP

All applications will be judged by a selection committee determined by AFLF board of directors; the selection committee reserves the right to use all scholarship any materials submitted to be deemed appropriate for review. The review of the application and awarding of the awards, bursaries, and/or scholarships take place monthly. The scholarship selection committee will be comprised of both academic and industry professionals as deemed appropriate by AFLF. Any and all decisions made by the selection committee are final, the final selected applicant (s) will need to provide a copy of their chosen post-secondary institution acceptance letter and proof of enrollment in order to receive the award, bursary, and/or scholarship (s).

Reviewer's base their evaluation and recommendations on the personal story conveyed in the essay or letters submitted: The point values for each question in the application are noted in the assessment criteria.

- o future aspirations,
- the importance of the chosen field of study, and
- o how the scholarship will help the applicant achieve academic, career, and personal goals.
